RESOLUTION

Pursuant to notice duly given, a meeting of the Western Carolina Regional Sewer Authority was held in the Offices of Hill, Wyatt & Fayssoux, Attorneys at Law, 100 Williams Street, Greenville, South Carolina, at 3:00 p.m. on Friday, January 28, 1977, for the purpose of determining just compensation and damages, if any, to be paid to Reginald Christopher and Glennis Christopher for the condemnation of a right-of-way across property described in the Greenville County Block Book records as being Sheet B3,1, Block 1, Lot 63, acquired by Reginald Christopher and Glennis Christopher by deed recorded in the RMC Office for Greenville County in Deed Book 1034 at Page 603.

BE IT RESOLVED by the Commissioners of the Western Carolina Regional Sewer Authority that the value of the right-of-way being taken, together with any special damage occasioned by the construction of the sewer line is in accordance with the applicable constitutional and statutory provisions, found to be One Thousand eight hundred fifty and No/100 (\$1,850.00) Dollars.

Let notice of this Resolution be promptly given to Reginald Christopher and Glennis Christopher and let a notice of this Resolution be promptly filed in the Office of the Clerk of Court for Greenville County, South Carolina. Check of the Authority in the amount of One Thousand Eight Hundred Fifty and No/100 (\$1,850.00) Dollars, payable to the property owners, is to be filed with the Clerk of Court at the time of the filing of this Resolution with the authority duly given to the Clerk of Court to deliver such check to the landowners.

It is directed that this Resolution be recorded in the RMC Office for Greenville County and cross-indexed in the name of Reginald ^{M.} Christopher and Glennis N. Christopher.
