W. Fore, Jr., Individually and as Administrator, C.T.A. of the Estate of Aubrey C. Fore, and Caroline M. Fore, Individually for the condemnation of a right-of-way across property described in the Greenville County Block Book records as being Sheet 82.1, Lots 15, 23 and 26, acquired by the said M. W. Fore, Jr., Individually and as Administrator C.T.A. of the Estate of Aubrey C. Fore and Caroline M. Fore, Individually, by deeds recorded in the RMC Office for Greenville County in Deed Book 267 at Page 183, Deed Book 271 at Page 404 and Deed Book 269 at Page 306. and from the Estate of Aubrey C. Fore.

BE IT RESOLVED by the Commissioners of the Western Carolina Regional Sewer Authority that the value of the right-of-way being taken, together with any special damage occasioned by the construction of the sewer line is, in accordance with the applicable constitutional and statutory provisions, found to be One Thousand Two Hundred Sixty Eight and No/100 (\$1,268.00) Dollars.

Let notice of this Resolution be promptly given to M. W. Fore, Jr., Individually and as Administrator C.T.A. of the Estate of Aubrey C. Fore and Caroline M. Fore, Individually and let a notice of this Resolution be promptly filed in the Office of the Clerk of Court for Greenville County, South Carolina. Check of the Authority in the amount of One Thousand Two Hundred Sixty Eight and No/100 (\$1,268.00) Dollars, payable to the property owners is to be filed with the Clerk of Court at the time of the filing of this Resolution with the authority duly given to the Clerk to deliver such check to the landowners.

It is directed that this Resolution be recorded in the RMC Office for Greenville County and cross-indexed in the name of M. W. Fore, Jr., Individually and as Administrator C.T.A. of the Estate of Aubrey C. Fore and Caroline M. Fore, Individually.
