ALL water lines, mains, valves and appurtenances installed and located in, under or along Cedar Creek Drive, Bubbling Creek Drive, and Kirksey Ct., County of Greenville, State of South Carolina, including approximately 1,835 feet, more or less, of 6" C. I. Pipe; 1,000 feet, more or less, of 2" Galvanized pipe; 6 - 6" valves, which will open right; 4 - 2" valves, which will open left; and 3 fire hydrants to be 3-way and open right, and is shown on a drawing entitled "L. H. Tankersley, As Trustee to Commissioners of Public Works of the City of Greenville, S. C.", dated January 27, 1977, attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to said lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and assigns against the grantor(s) and the grantor's(s') heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
