the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto SAM L. GAULT, his heirs and assigns forever;

ALL that piece, parcel or tract of land, lying and being situate in the County of Greenville, State of South Carolina, and being shown as Tract No. 3 on a plat prepared for Sam L. Gault and Paul E. Gault by Morgan & Applewhite Engineering Associates on January 6, 1977, with said tract to contain 49.417 acres excluding road rights-of-ways and being more particularly described according to said plat with the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western edge of Road S-23-154 (which road leads to Fork Shoals) and said iron pin being at the joint front corners of Tracts 2 and 3 and running thence along the western edge of said road S. 33-44 W. 428.3 feet to point; thence S. 42-21 W. 524.9 feet to a point; thence leaving said road and running as follows: N. 82-24 W. 779.7 feet to an old stone corner; thence N. 6 -41 E. 101.0 feet to an old stone corner; thence N. 82-36 W. 1378.5 feet to an old iron pin; thence N. 3-44 E. 356.7 feet to an old stone corner and new iron pin; thence N. 3-06 E. 583.6 feet to a new iron pin at the joint rear corner of Tracts 2 and 3; thence along the joint boundary line of Tracts 2 and 3 S. 77-55 E. 2720.0 feet to the point of beginning.
