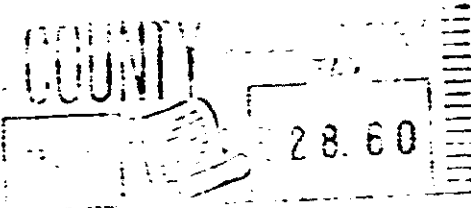
in consideration of Twenty Five Thousand Nine Hundred and No/100 (\$25,900.00)----- Dollars,
