TITLE TO REAL ESTATE

Know All Men by These Presents:

That Harbor Town Limited Partnership, a S.C. Limited Partnership hereafter referred to as Grantor, in consideration of the sum of Twenty-Three Thousand Five Hundred (\$23,500.00) DOLLARS, paid to Grantor by Julia A. Medlin, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee her heirs and assigns forever:

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 91 on plat of Harbor Town, recorded in the R.M.C. Office for Greenville County in Plat Book 5P, at Pages 13 and 14, and being more particularly described as follows:

BEGINNING at a point at the joint corner of Units 91 and 92 and thence running S 18 - 30E 68.8'; thence turning and running S 71-30W 20.4'; thence turning and running N 18 - 30W 68.8'; thence turning and running N 71 - 30E 20.4' to the point of Beginning.
