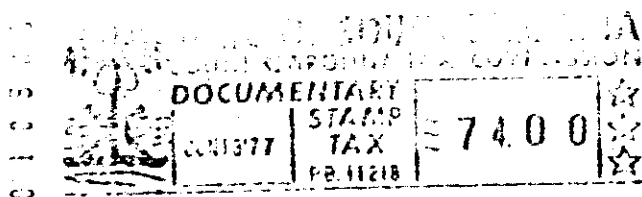
KNOW ALL MEN BY THESE PRESENTS, that WE, MICHAEL STEVEN WILSON AND LINDA R. WILSON
