to the grantor in hand paid at and before the sealing of these presents by the grantees, the receipt of which is hereby acknowledged, have granted, bargained, sold and released by these presents do grant, bargain, sell and release unto JASPER S. TRIPP and BERNICE T. LINDSEY, as TRUSTEES, their successors and assigns forever: PARCEL NO. 1:

ALL that tract of land in Saluda Township, Greenville County, State of South Carolina, on the Western side of New Buncombe Highway (U. S. Highway No. 25) about 18 miles northwest of the City of Greenville, containing 23.09 acres, more or less, and according to a survey made by J. C. Hill on February 26, 1949, is described as follows:
