RALPH E. CARREL AND DOROTHY N. CARREL, THEIR HEIRS AND ASSIGNS FOREVER:

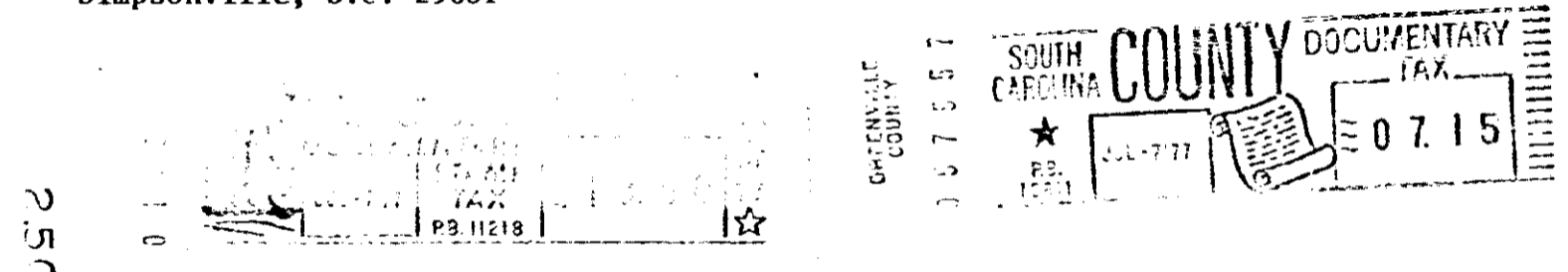
