POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, Pearle B. Wyatt, hereby appoint J. W. Ballentine and Betty Jean Ballentine ofasley, South Carolina, my attorneys for me and in my name and stead, to do and to execute all or any of the following acts, deeds and things, as fully as I might or could do if personally present, to-wit:

1. To ask, demand, collect, recover and receive all sums of money, debts, accounts, interest, dividends, annuities, pensions and demands or other entitlements whatsoever as are now or shall hereafter become due, owing, payable or belonging to me and to deposit such money in and to my account in any financial institution.
2. To write checks on and draw on my account and sign checks in my name, and to use the money obtained from said account for the purpose of paying any and all of my debts arising from business, personal or medical sources and to do whatsoever other thing that is necessary and proper for the conduct of my affairs until such time as this instrument is revoked.
3. To borrow from time to time such sums of money and on such terms as they may deem advisable or expedient for and in relation to any of the purposes or obligations set forth herein, on the security of any of my property, whether real or personal.
4. To sell and convey all of my right, title and interest in and to any of my property of whatsoever nature for such price and upon such terms and conditions as to them shall seem advisable.
5. To sign any instrument or legal document in my name pertaining to any of my business affairs, including income tax returns, questionnaires or reports.
6. To execute all necessary instruments, to carry out and perform any of the foregoing powers and to do any other acts requisite to the carrying out of such powers.
7. This Power of Attorney shall become effective upon delivery to my attorneys. This Power of Attorney may be revoked by an instrument of revocation recorded in the office of the Clerk of Court for Anderson County, South Carolina, and until said revocation is thus recorded, all acts of my attorneys are hereby ratified and affirmed.
