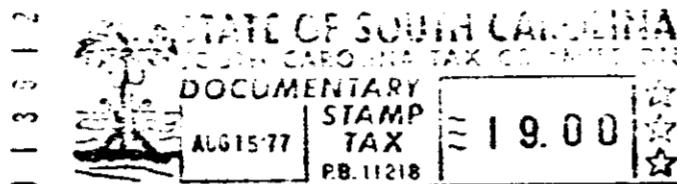

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said COTHRAN & DARBY BUILDERS, INC., its successors and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northwesterly side of Grey Stone Court, near the City of Greenville, S. C., being known and designated as Lot No. 197 on plat entitled "Map No. 2, Section I, Sugar Creek" as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4R, page 85 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Grey Stone Court, said pin being the joint front corner of Lots 197 and 198 and running thence with the common line of said lots N 36-57-59 W 142.51 feet to an iron pin, the joint rear corner of Lots 197 and 198; thence N 55-50-48 E 100.12 feet to an iron pin, the joint rear corner of Lots 196 and 197; thence with the common line of said lots S 36-57-59 E 137.60 feet to an iron pin on the northwesterly side of Grey Stone Court; thence with the northwesterly side of Grey Stone Court S 53-02-01 W 100 feet to an iron pin, the point of beginning.
