(2) Only one single family residence allowed on this lot; minimum house size 1,400 square feet, living area.

Single wide mobile home now allowed. Double wide on permanent brick or block foundation allowed. Must have a minimum of 24" ground clearance at the lowest point. Minimum double wide size 24' x 55'.

Temporary single wide mobile home allowed for up to one year during construction of permanent house. Foundation for house must be constructed before mobile home can be placed on property. )
