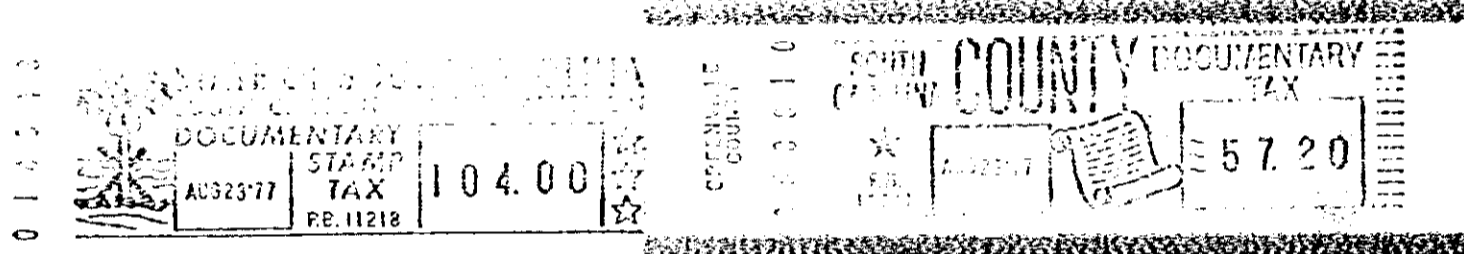
KNOW ALL MEN BY THESE PRESENTS, that Cunningham and Summers Associates, a General Partnership
