the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

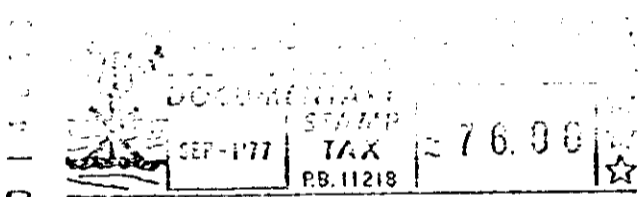
JOSEPH V. DARNELL and NIKKI A. DARNELL, their heirs and assigns forever.
