KNOW ALL MEN BY THESE PRESENTS that I, J. W. L. Morris, et al., do hereby make and declare the following:

in consideration of Lot 12 and 13 located on the corner of 13th and Main Streets, Greenville, S.C. 29605 Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto

Harry Edward Bowling, his heirs and assigns, forever,

All that piece and parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township on the Eastern side of Melvin Boulevard now known as 13th Boulevard partly in and partly out of the City of Greenville, in the southerly half of Lot No. 21, Block 3 according to a plat of Survey of Surveyor's Office Company (now named as Melvin Bou. Land Survey Corporation) recorded in the U.S. Office for Greenville County in Lot Book 11 at pages 22 and 23 and having, according to said plat, the following corner and bounds, to-wit:

A certain lot of land on the Eastern side of Melvin Boulevard now known as 13th Boulevard, at the joint corner of Lots Nos. 13 and 20 and running thence with the joint line of said lots, .7175 ft. 20 feet to a stake in the dividing line of Lots Nos. 12 and 13; thence N. 14-15 E. 177 feet to a stake in the corner of Lots Nos. 3, 4, 20 and 12; thence S. 6-7 E. 130 feet to a stake on Melvin Boulevard now known as 13th Boulevard; thence with the Eastern side of said Boulevard in a southerly direction 15.7 feet to the point of beginning;
