release unto MARILYN P. HEUER, Her Heirs and Assigns, Forever:

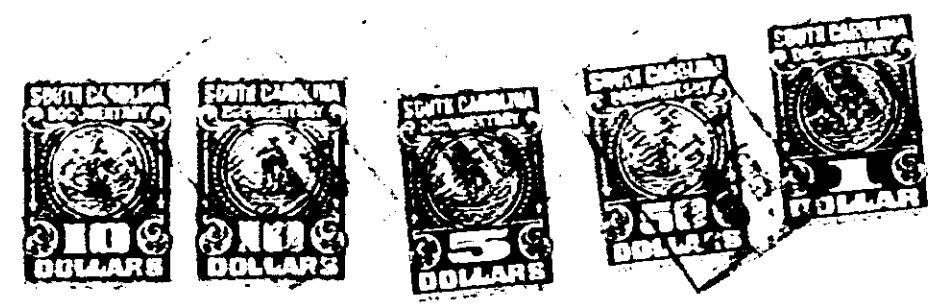
ALL that certain piece, parcel or lot of land, with all improvements thereon, situate, lying
