This is the same property conveyed to the grantor herein by deed recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 245 at Page 122.

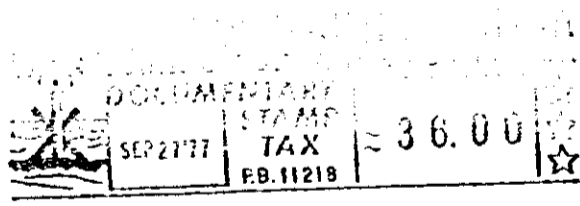
