I. pipe; 880 feet, more or less, of 2" galvanized pipe; 2 - 6" valves, to open right; 1 - 2" valve, to open left; and 1 fire hydrant, to be 3-way and open right, and is shown on a drawing entitled "Devenger Road Land Co., A Partnership to Commissioners of Public Works of the City of Greenville, S. C.", dated September 1, 1977, attached hereto and made a part of this conveyance.
