**BUILDERS & DEVELOPERS, INC.,** its successors and assigns forever:

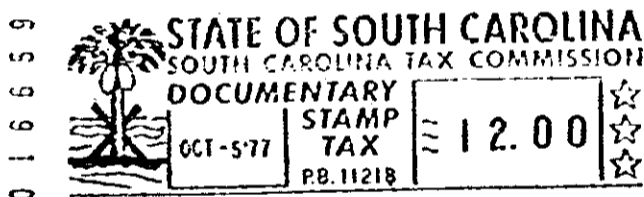
