ALL water lines, mains, valves and appurtenances installed and located in, under or along Frontage Road at I-85, County of Greenville, State of South Carolina, including approximately 2,954 feet, more or less, of 8" C.I. pipe; 49 feet, more or less, of 6" C.I. pipe; 1-8" valve, to open right; 4- 6" valves, to open right; and 4 fire hydrants to be 3-way and open right, and is shown on a drawing entitled "Archie L. Honbarrier to Commissioners of Public Works of the City of Greenville, S.C." dated August 26, 1977, attached hereto and made a part of this conveyance.
