in consideration of an exchange of real estate valued at \$300.00----- Dollars,

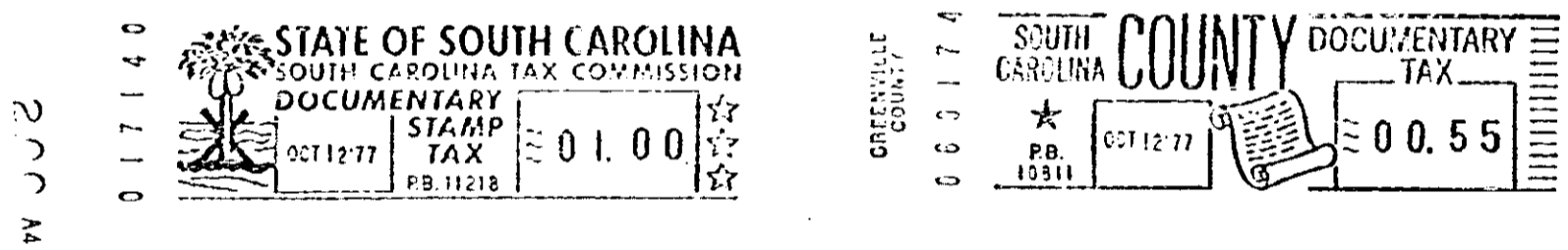
