JOHN H. HEMBREE AND ANN M. HEMBREE, their heirs & assigns forever:

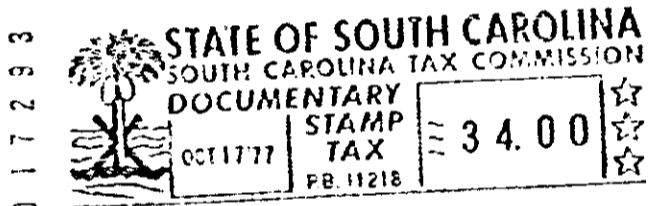
