

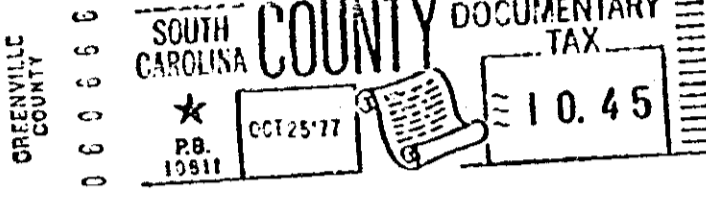
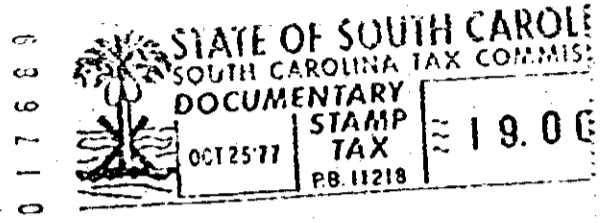

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northwesterly side of Oak Ridge Court, near the City of Greenville, being known and designated as Lot No. 181 on plat entitled "Map No. 2, Section I, Sugar Creek" as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4R, page 85 and having, according to said plat, the following metes and bounds, to-wit:
