ALL that piece, parcel or lot of land in the City and County of Greenville, State of South Carolina, on the northeastern side of Ware Street, and having, according to a recent survey made by Campbell & Clarkson entitled "Property of Mattie Mae Kinsey" recorded in the RMC Office for Greenville County in Plat Book VVV, at Page 41, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Ware Street, said pin being 418 feet north of the intersection of Ware Street and Rhett Street and running thence, N. 70-36 E. 100 feet to an iron pin; thence S. 19-00 E. 50 feet to an iron pin; thence, S. 70-36 W. 100 feet to an iron pin on the northeastern side of Ware Street; thence with the northeastern side of Ware Street, N. 19-00 W. 50 feet to an iron pin, the point of beginning.
