In consideration of Two Thousand and No/100-----Dollars,

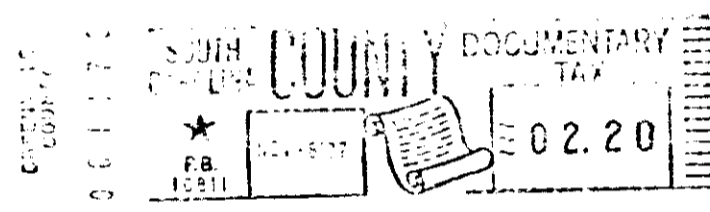
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Vera E. Cooke, her heirs and assigns forever:

ALL that piece, parcel or lot of land, situate, lying and being in the County of Greenville, Bates Township, State of South Carolina, and being located on the eastern side of S. C. Highway 25, north of Travelers Rest, South Carolina, being shown as the Property of Vera E. Cooke, by plat prepared by Terry T. Dill Reg. CE & LS, dated May 4, 1973, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of S. C. Highway 25 which is 450 feet north of the Duke Power right-of-way and being joint front corner of property of the Grantor; thence with the eastern side of S. C. Highway 25, N. 31-00 E. 125 feet to an iron pin; thence S. 79-32 E. 250 feet to an iron pin; thence S. 31-00 W. 125 feet to an iron pin; thence N. 79-32 W. 250 feet to the beginning corner.

This being the same property conveyed to Ben Robertson and Jane E. Robertson from Lena W. Edwards by deed recorded in the RMC Office for Greenville County, S. C., in Deed Book 974, Page 498, recorded May 14, 1973.
