TITLE TO REAL ESTATE

Know All Men by These Presents:

That Julian Pelham Hopkins, hereafter referred to as Grantor, in consideration of the sum of Nineteen Thousand, Two Hundred and no/100 -- (\$19,200.00) DOLLARS, paid to Grantor by J. Drayton Hopkins, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, his heirs and assigns forever:

ALL that certain piece, parcel or tracts of land situate, lying and being in Oaklawn Township, Greenville County, South Carolina, containing 19.20 acres, more or less, and being known and designated as Tracts No. 12, 13 and 14 of property of Julian Hopkins by Bakkum-DeLoach & Associates dated August 5, 1977, and recorded in the R.M.C. Office for Greenville County in Plat Book 6C, at Page 33, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Fork Shoals Road, joint front corner of Tracts 11 and 12 of property of Julian Hopkins, and running thence along Tract 11 of said property, N. 88-28 E. 1242.76 feet to an iron pin in the line of other property of J. Drayton Hopkins, the grantee herein, which point is also the joint rear corner of Tracts 12 and 11; thence turning and running along the line of other property of J. Drayton Hopkins, the grantee herein, S. 41-11 W. 1832.31 feet to an iron pin on the east side of Fork Shoals Road, joint front corner of Tract 14 and other property of J. Drayton Hopkins, the grantee herein; thence turning and running along the east side of Fork Shoals Road, N. 1-30 W. 745.89 feet to an iron pin on the east side of Fork Shoals Road; thence continuing along the east side of Fork Shoals Road, N. 1-32 W. 600 feet to iron pin on the east side of Fork Shoals Road, the beginning corner.

Being a portion of the property owned by Nellie K. Hopkins, deceased, at the time of her death. The said Nellie K. Hopkins died testate leaving of force her Last Will and Testament dated July 16, 1957 and First Codicil thereto dated October 11, 1971, both of which are on file in the Office of the Probate Court for Greenville County in Apartment 1249, File 7.

By the terms of Item VII (B) of her Will, the said Nellie K. Hopkins devised and bequeathed unto the grantor herein a portion of her real property of which the above described tract is a part, to be his absolutely and in fee simple.

As a part of the consideration for this deed, the grantee, his heirs, administrators, executors, successors and assigns, agrees that the above described property shall not be used for the sale of used cars or used car parts nor shall the same be used for a junk yard. 12.30 Ac

TO HAVE AND TO HOLD all and singular the said premises before mentioned unto the Grantee and Grantee's Heirs/Successors and Assigns forever. AND Grantor does hereby bind Grantor and Grantor's Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto Grantee and Grantee's Heirs/Successors and Assigns against Grantor and Grantor's Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
