All those certain pieces, parcels or lots of land, situate, lying and being on the Southern side of Columbia Avenue, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 5 and 6 of Block I, as shown on a Plat entitled "Riverside", prepared by P. H. Foster, R.S., dated October 1909 and recorded in the RMC Office for Greenville county, South Carolina in Plat Book A at Pages 322 and 323, and replated in Plat Book K at Pages 281 through 284, and having according to said Plats the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Columbia Avenue at the joint front corner of Lots Nos. 4 and 5 and running thence with the line of Lot No. 4, S. 10-15 W. 125 feet to an iron pin at the joint rear corner of Lots Nos. 4 and 5 on the Northern side of a 15 feet alley; thence with the rear line of Lots Nos. 5 and 6 and along the Northern side of said 15 foot alley S. 79-45 E. 100 feet to an iron pin at the joint rear corners of Lots Nos. 6 and 7; thence with the line of Lot No. 7 N. 10-15 W. 125 feet to an iron pin on the Southern side of Columbia Avenue at the joint front corner of Lots Nos. 6 and 7; thence along the Southern side of Columbia Avenue N. 79-45 W. 100 feet to the point of beginning.
