Greenville, State of South Carolina, in consideration of Ten and No/100 Dollars (\$10.00)

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and  
release unto  
Jerry L. Sherman and Jeanette M. Sherman, their heirs and assigns, forever:

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina,  
County of Greenville, in the Town of Mauldin, being a portion of Lot 98, Forrester Woods,  
Section II, plat of said subdivision being recorded in the R.M.C. Office for Greenville  
County, S. C., in Plat Book 4-X, at page 64, said portion being a 5-foot strip of land  
directly North of Lot 95, fronting 5 feet on Over Creek Road and having the following metes  
and bounds, to-wit:

BEGINNING at a point on Over Creek Road at the joint front corner of Lots 95 and 98 and  
running with said Road N. 11-13 E. 5 feet to a point; thence turning and running S. 78-47 E.  
150 feet to a point; thence turning and running S. -11-13 W. 5 feet to a point; thence turning  
and running N. 78-47 W. 150 feet to the point of beginning.

It is the intention to grant to Grantees herein additional five (5) feet of width along the  
northern boundary of Lot 95, said five feet being subtracted from Lot 98 which is located  
directly to the north of Lot 95.

This conveyance is made subject to any restrictions, reservations, zoning ordinances,  
or easements that may appear of record, on the recorded plat(s), or on the premises.

The YBH Development Co., Inc., a South Carolina corporation was changed to YB  
Developers, Inc. by Articles of Amendment filed May 19, 1972, with the Secretary of  
State of South Carolina.
