All that certain piece, parcel or lot of land, situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, being a part of the land conveyed to Joe A. Phillips by deed of Jerry Phillips recorded in the PMC Office for Greenville County in Deed Book 429, at Page 105, and also being known as Lots No. 10 and 12 as per plat and survey of Morrow, L.S., recorded in Plat Book AA, at Page 179, and having the following metes and bounds, to-wit:
