ALL that certain piece, parcel or tract of land containing ten (10) acres, more or less, situated, lying and being in the County of Greenville, State of South Carolina and being a part of the Estate of the late Rev. Thomas B. Butler as shown; per plan recorded in the R. M. S. Office for Greenville County at Flat Rock Rd., page 43, as a part of Tract 1, and having the following metes and bounds:

"BEGINNING at an iron pin at the intersection of the property known as Tract 1 and Tract 1 as shown per plan referred to hereinabove, S 73° 45' W 277.16 feet to an iron pin; thence N 11° 20' E 371.00 feet to an iron pin; thence S 73° 45' E 100.0 feet to an iron pin on the westerly side of a dirt road; thence S 47° 55' E 777.1 feet along said dirt road to an iron pin; thence S 24.42 E 111.79 feet to the point of beginning."
