pursuant to the Will of Herbert Milton Farr
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell
and release unto Ruth F. Presnell, her heirs and assigns forever:

ALL our undivided right, title and interest in and to the following described property: All that piece, parcel or lot of land located in Berea Community Greenville County, State of South Carolina and being shown and designated as a 3.32 acre tract of land on plat of property of Ruth F. Presnell, said plat being prepared by Terry T. Dill, Registered Surveyor, and dated November 22, 1977, recorded in the R.M.C. office for Greenville County in Plat Book 6-4 at page 82, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the joint corner of property of the Grantee and Philpot, and running thence N. 69-06 E., 784 feet to an iron pin; thence S. 13-07 E., 214 feet to an iron pin; thence S. 46-36 W., 142 feet to an iron pin on the northern side of a creek; thence with the creek as the line, in a southwesterly direction, the traverse line of said creek being as follows: S. 80-00 W., 177 feet to an iron pin; thence continuing the traverse line of the creek, S. 86-30 W., 325 feet to an iron pin on the southern side fo the creek; thence crossing the creek N. 67-00 W., 196 feet to an iron pin, the point of beginning.
