All that certain piece, parcel or lot of land, together with the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville on the Northerly side of Kenwood Lane (formerly known as Weston Avenue) in the City of Greenville being known as Lot No. 29 on a Plat of North Park made by Dalton & Neves dated May, 1910 and revised in February, 1911 recorded in Plat Book 1 at pages 18 and 19 and having the following description:
