All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot "B" on a plat of Property of Ernestine Massey, prepared by Webb Surveying and Mapping Co. on 10-15-69, and recorded in the R.
