ALL that piece, parcel of lot of land near the City of Greenville, State of South Carolina, being known and designated as part of Lot # 3, of a subdivision known as Fore Estates, as shown on a Plat thereof, dated March, 1952, made by Dalton & Neves, Engineers, and, after having a survey by Carolina Engineering & Surveying Company, dated 29 December, 1972, having metes and bounds, for purposes of conveying one-half (1/2) of said Lot # 3, to-wit:
