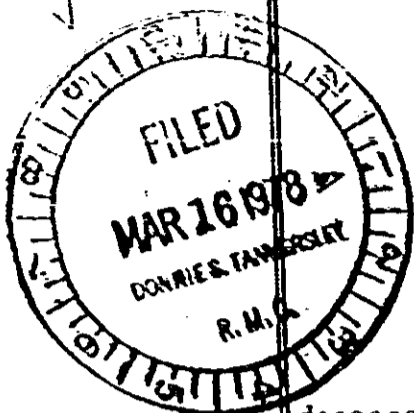

KNOW ALL MEN BY THESE PRESENTS:

That I, HAZEL E. GUEST, Executrix of the Estate of Stanley R. Guest, deceased, in compliance with the Will of Stanley R. Guest, deceased, which Will was filed on the 17th day of May, 1977, in the Lake County Common Pleas Court, Probate Division, Lake County, Ohio, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HAZEL E. GUEST, whose address is 4741 Willocroft Road, Willoughby, Ohio, 44094, and to her heirs and assigns, all that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, School District 12 B, having the following metes and bounds, to-wit:

PARCEL NO. 1 - BEGINNING at an iron pin the Old Road joint corner of John Guest Estate, thence N. 62 1/2 E., 2 chains to an iron pin in the Old Road; thence N. 55 W., 17 chains to an iron pin; thence S. 77 1/2 W., 1.48 chains to an iron pin in road; thence S. 12 E., 92 links to an iron pin; thence S. 55 E., 16.20 chains to iron pin at the BEGINNING corner, and containing 2 7/8 acres as is shown by a plat made by W. A. Hester, Surveyor, January 2, 1941.

PARCEL NO. 2 - All that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, near Marietta and being known and designated as Tracts Nos. 2 and 3, according to a survey and plat of W. A. Hester, dated November 29, 1921, and being a part of the John Guest Estate, Tract No. 2 containing 32.92 acres, more or less, Tract No. 3 containing 39.33 acres, more or less, and more particularly described as follows:

Tract No. 2. Beginning at a stone on corner of Tract No. 1 and Tract No. 2 and running N. 32-52 W. 27.30 to stone on; thence S. 3 3/4 W. 39.50 to stone on; thence N. 68 1/2 E. 1.90 to stone on; thence S. 40 1/2 E. 1.40 to stone at mouth of branch; thence N. 41 E. 22.50 to the beginning corner.

Tract No. 3. Beginning at a stone on Saluda River, the southeastern corner of Tract No. 1 on said river, and running thence N. 10 W. 5.80 to Hickory on; thence N. 51 1/2 W. 10.68 to pine on; thence N. 17 W. 15.30 to iron pin; thence N. 45 W. 8.00 to iron pin; thence N. 10 1/4 W. 4.75 to iron pin on in line of lands of Eddie Guest; thence along the line of Eddie Guest land S. 55 1/4 E. 39.00 to a point on Saluda River near a spring; thence along said Saluda River 19.30 chains to the beginning corner. consideration being love, affection and compliance with the Will of Stanley GUEST TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
