Know All Men by These Presents:

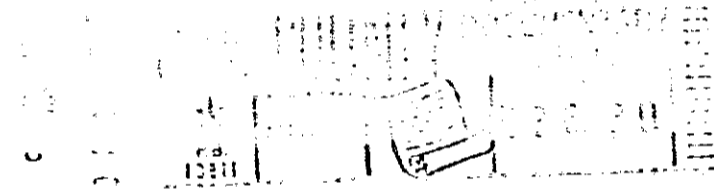
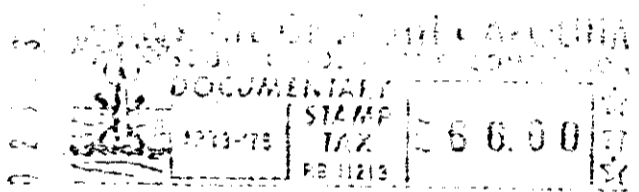

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 61 on plat of Harbor Town, recorded in the R.M.C.
