All my interest in that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, about three miles west of the city of Greer, S. C., lying on the east side of the Rutherford Road, and being a part of tract No. 1 as shown on Plat of property of James Calvin Suber, et al., said plat made by H. S. Brockman, Surveyor March 21st 1955, and having the following courses and distances, to wit:-

Beginning on a point in the center of the said Rutherford Road, said point being 32 feet, more or less, from the northwest corner of my home lot (Tract No. 2 on said plat), and runs thence a new line, N. 75-37 E. 25 feet to an iron pin on the eastern margin of the said road, then continuing with the same course for a total distance of 276.4 feet to an iron pin; thence N. 8-30 W. 220 feet to an iron pin; thence S. 84-56 W. 275.5 feet to a point in the center of the said road (iron pin back on line at 25.5 feet); thence with the center of the said road, S. 8-30 E. 264 feet to the beginning point, containing One and Fifty Two One-hundredths (1.52) Acres, more or less.
