BEGINNING at an iron pin on the East side of LeGrand Boulevard at joint front corner of Lots 1 and 2 and running thence with the line of Lot 1, N 88-30 E 150 feet to an iron pin; thence N 1-30 W 73 feet to an iron pin thence with the line of Lot 3, S 88-30 W 150 feet to an iron pin on the East side of LeGrand Boulevard; thence with the East side of LeGrand Boulevard, S 1-30 E 73 feet to the beginning corner.
