WITNESSETH: That the said grantor(s) for and in consideration of the sum of Twenty Seven Thousand
Nine Hundred and No/100----- Dollars (\$ 27,900.00),

to it in hand paid by the Grantee(s), the receipt whereof is hereby acknowledged, ha^s

granted, bargained, sold and conveyed and by these presents do es grant, bargain,
sell and convey unto the said Grantee(s) for and during their joint lives and upon the death of either of them, then to the
survivor of them, his or her heirs and assigns forever in fee simple, together with every contingent remainder and right of

reversion, the following described land, lying and being in the County of Greenville

State of South Carolina, to-wit:

ALL that piece, parcel or lot of land situate, lying and being in the
State of South Carolina, County of Greenville, Austin Township on the
Northeast side of Corkwood Drive, and being known and designated as
