Said property is described as follows: BEGINNING at a stake on the Southwesterly side of Harrington Avenue at a point 296.9 feet Northwest from Prescott Street at the corner of Lot No. 49 and running thence along the line with said Lot. S. 39-25 W. 164.8 feet, more or less, to a stake on Spartanburg Street; thence along the Norterly side of Spartanburg Street N. 66-59 W. 73 feet, more or less, to a stake at the corner of Lot No. 51; thence along the joint line with Lot No. 51 N. 39-25 E. 185.6 feet, more or less, to a stake on Harrington Avenue; thence along the Southwesterly side of Harrington Avenue S. 50-35 E. 70, feet, more or less, to the point of beginning.
