Know All Men by These Presents:

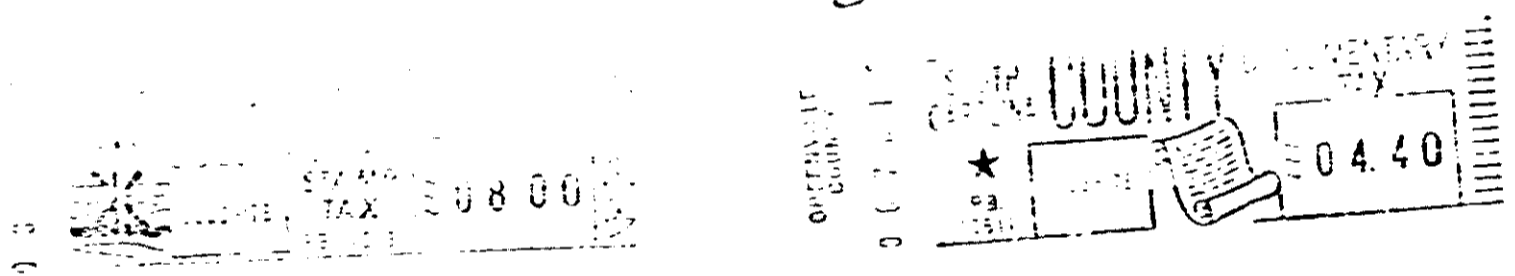

Huff hereafter referred to as Grantor, in consideration of the sum of Four Thousand and No/100 (\$4,000.00) DOLLARS, paid to Grantor by Leonard Hendricks and Mirinda Hendricks hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, will and release unto the said Grantee

ALL that certain piece, parcel or tract of land, situate, lying and being in the State of South Carolina, County of Greenville, located approximately 3 miles south of The Ware Place, containing 1.01 acres, more or less, as shown on a survey of John C. Smith, R.L.S., dated May 24, 1978, and according to said survey, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Augusta Road, joint corner of property now or formerly of John D. Huff, and running thence with said Augusta Road N. 34-21 W. 92.44 feet to an iron pin; thence continuing along Augusta Road N. 30-44 W. 118.88 feet to an iron pin on the southeastern side of a 50 foot proposed street; thence turning and running along the southeastern side of said proposed street N. 63-16 E. 252 feet to an iron pin; thence turning and running S. 30-21 E. 140.7 feet to an iron pin; thence turning and running S. 47-05 W. 250.26 feet to an iron pin, the point of beginning.
