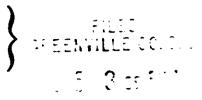

BEGINNING at an iron pin on the Southeasterly side of Briar Creek Road said pin being the joint front corner of Lots 100 and 101 and running thence with the common line of said lots S 57-26 E 152.24 feet to an iron pin the joint rear corner of Lots 100 and 101; thence S 40-38 W 106.05 feet to an iron pin the joint rear corner of Lots 99 and 100; thence with common line of said lots N 57-26 W 137.35 feet to an iron pin on the Southeasterly side of Briar Creek Road; thence with the Southeasterly side of Briar Creek Road N 32-34 E 105 feet to iron pin the point of beginning.

This conveyance is subject to a 25 foot sewer right of way and 10 foot drainage easement across the rear point of the lot and is subject toall restrictions, setback lines, roadways, easements and right of ways, of any, affecting the above described property.
