KNOW ALL MEN BY THESE PRESENTS, THAT I (or we) Mt. Emanuel Baptist Church

in consideration of the sum of One Dollar, to me (or us) in hand paid, and other valuable consideration at and before sealing and delivering thereof, by the City of Greenville, receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell, and release, unto the said City of Greenville, its successors and assigns, a right-of-way for the construction of a section of the City Roadway, including necessary drainage ditches and sidewalks from

East Stone Ave. to East North Street on

Spartanburg Street State and County aforesaid, as shown by plans prepared by the City of Greenville on and over all land which I (or we) own and are further described below, for the purpose of locating, constructing improving, and maintaining the above described highway with the bridges and causeways thereon, and the right to construct and maintain controlled access facilities to said highway:

Said property is described as follows: ALL that lot adjacent to Lot designated 188.1-7-5 beginning at an iron pin on the north side of Old Spartanburg Road, corner of Lots Nos. 1 and 2, and running thence with said road N. 52-45 E. 40 ft., more or less, to an iron pin, corner of Lot No. 3; thence with said line N. 40 W. 104.5 feet, more or less, to an iron pin, in line of Lot No. 5; thence with said line S. 57-30 W. 40.1 feet, more or less, to an iron pin, corner of Lot No. 1; thence with line of said lot S. 40 E. 108.5 feet, more or less, to the beginning corner.

Said right-of-way is described as follows: BEGINNING at a point on the northwestern side of Spartanburg Street at the joint corner of Lots 188.1-7-5 and 188.1-7-6 and running thence in a northeasterly direction along Spartanburg Street 40 feet, more or less, to the joint line with 188.1-7-8, said easement or right-of-way containing any and all portions of the above-described property between baseline and a line designated proposed right-of-way shown on a plat prepared by W. R. Williams, RE & LS, October 1976, and filed in the RMC Office of the County of Greenville, Plat book SX, at page 11-24.

"Special Provisions:" The City of Greenville is committed to building a retaining wall contiguous to the new Spartanburg Street to assure the retention of soil from the above described property.

Together with, all and singular, the rights, members, hereditaments and appurtenances thereunto belonging, or in any wise incident or appertaining. It is agreed that buildings, fences, signs or other obstructions will not be erected by me (or us), my heirs, assigns or administrators within the limits of the right-of-way herein conveyed and that such buildings and fences as are now within the limits of the right-of-way herein conveyed will be moved from the right-of-way and restored in as good condition as before moving at the expense of the City of Greenville, South Carolina.

TO HAVE AND TO HOLD, all and singular, the said right-of-way and the rights herein before granted, unto the said City of Greenville, its successors and assigns forever.
