ALL that piece, parcel or lot of land situate on the southeastern side of Caledonia Road and on the northwestern side of West Lake Shore Drive in the County of Greenville, State of South Carolina being shown as Lot 1066, Lot 1068, Lot 1070, Lot 1072 and Lot 1074 on a plat of Lake Lanier Subdivision dated June 6, 1925, prepared by George Kershaw, recorded in Plat Book G at page 35 in the RMC Office for Greenville County and also being shown as a tract containing 1.27 ac. on the plat of the Property of Eustace B. Smeed and Lila I. Smeed dated September 1972, prepared by Sam T. BEGINNING at an iron pin on the southeastern side of Caledonia Road at the joint front corner of Lot 1074 and Lot 1076 and running thence with Lot 1076 S 64-02 E 158.30 feet to an iron pin on the western side of West Lake Shore Drive; thence with said drive, the following courses and distances: N 21-56 E 50 feet, N 25-48 E 49.30 feet, N 44-11 E 35.70 feet, N 71-13 E 35.70 feet, S 73-37 E 35.70 feet to an iron pin at the joint corner of Lot 1064 and Lot 1066; thence with Lot 1064 N 32-00 E 196.51 feet to an iron pin on Caledonia Road; thence with said road the following courses and distances, to-wit: N 79-31 W 108.29 ft., S 82-41 W 86 feet, S 53-39 W 90.73 feet, S 38-07 W 72.95 feet, S 27-54 W 86.32 feet, S 38-47 W 46.71 feet to the point of beginning.
