KNOW ALL MEN BY THESE PRESENTS, that Janet M. Parham

in consideration of Three Thousand Eight Hundred Ninety-seven and 69/100 (\$3,897.69) Dollars and assumption of the mortgage indebtedness set forth below the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto George Nolin and Carmen Nolin, their heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, lying on the southern side of Circle Drive near the City of Greenville, being known and designated as Lot No. 19 of Franklin Heights, made by Dalton & Neves, Engineers, November, 1940 on plat recorded in the R.M.C. Office for Greenville County in Plat Book L at Page 9 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Circle Drive, at the joint front corner of Lots 19 and 20 and said pin being 546 feet in a northwesterly direction from the northwest corner of the intersection of North Franklin Road and Circle Drive, and running thence with the line of Lot 20, S. 20-00 W., 157.2 feet to an iron pin; thence with the rear line of Lot 6, N. 72-23 W., 75.0 feet to an iron pin; thence with the line of Lot 18, N. 20-00 E., 153.2 feet to an iron pin on the southern side of Circle Drive; thence with the southern side of Circle Drive, S. 75-40 E., 75.35 feet to the beginning corner.

This is the same property conveyed to the Grantor herein by deed of Stephen V. & Sheila V. Cushman recorded in the R.M.C. Office for Greenville County in Deed Book 1054 at Page 450 on the 11th day of April, 1977.

As part of the consideration of this deed, the Grantees agree to assume and pay in full the indebtedness due on the note and mortgage covering the above described property owned by Cameron-Brown Company dated September 30, 1975 and recorded October 1, 1975 in the R.M.C. Office for Greenville County in REM Book 1350 at Page 75, re-recorded October 15, 1975 in Book 1351 at Page 247 which has a present balance due in the sum of \$16,602.31.

The grantees assume and agree to pay Greenville County property taxes for the year 1978 and subsequent tax years.
