SYBAL OAKLAND, her heirs and assigns forever;

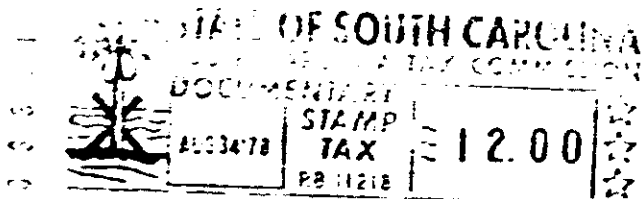
