

TITLE TO REAL ESTATE

KNOWN ALL MEN BY THESE PRESENTS, that Ethel Blakely, 103 Deoleoly Avenue Greenville, S.C.

in consideration of One Dollar & no/100's -----(\$1.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto The City of Greenville, a Municipal Corporation, P.O. Box 2207, Greenville, SC 29602, its successors and assigns:

ALL that piece, parcel or lot of land lying and being in the City of Greenville, County and State aforesaid, and lying on the northern side of Gower Street and having the following metes and bounds, to-wit:

BEGINNING at the corner of Sallie J. Johnson's lot on Gower Street and running thence along Gower Street S. 65-50 E. 50 feet, more or less, to a stake; thence N. 28-50 E. 217.5 feet, more or less, to a stake; thence N. 61-50 W. 50 feet, more or less, to a stake on Sallie J. Johnson's line; thence S. 28-50 E. 217.5 feet, more or less, to Gower Street, the beginning corner. This lot is known and designated as Block Book No. 76.3-6-37.

This is the same property conveyed to T. H. Johnson from O. P. Mills, Trustee for S.C. Mills, M.C. Crowell, A. G. Gower, Charles E. Gower and Lola C. Carpenter and is recorded in Deed Volume RRR, page 497, on January 24, 1906.

T. H. Johnson died testate some time in the 1930's. His will is now being probated in the Probate Court for Greenville County, but no number has yet been assigned to the file. By the will, Ethel Blakely, the grantor herein, has an undivided 1/4 interest in fee as tenant in common with Sallie Johnson, James Johnson, and Matthew Johnson, subject to the life estate in favor of Horace Johnson. The City assumes all stamps and recording fees of record.
