ROBERT H. WYNNE, JR., HIS HEIRS AND ASSIGNS FOREVER:

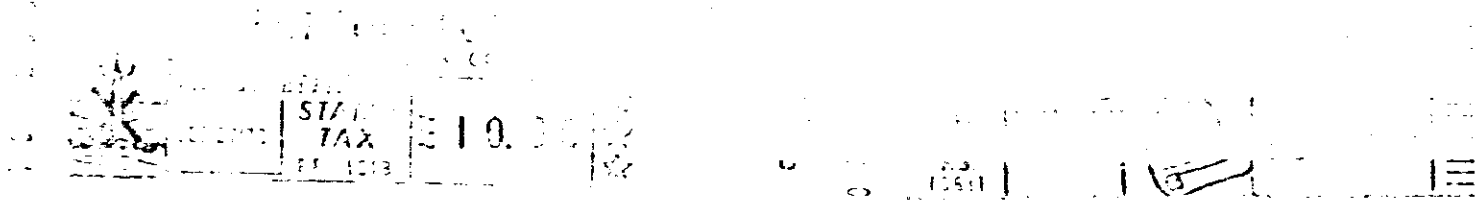
