in consideration of the sum of TWO THOUSAND AND NO/100 DOLLARS,

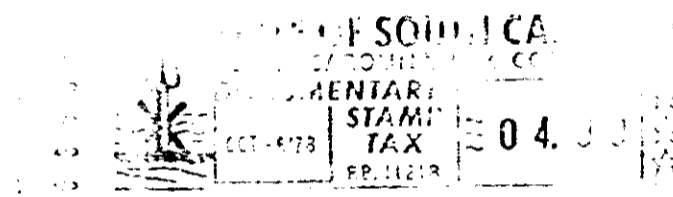
