the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto THE COMMISSIONERS OF PUBLIC WORKS OF THE CITY OF GREENVILLE, S. C., their successors and assigns:

ALL water lines, mains, valves and appurtenances installed and located in, under or along Cardington Ave., Charlwood Ave., Carversham Row, and Copperfield Ave., County of Greenville, State of South Carolina, including approximately 930 feet, more or less, of 8" D. I. pipe; 1,240 feet, more or less, of 6" D. I. pipe; 440 feet, more or less, of 2" galvanized pipe; 1 - 8" valve to open right; 5 - 6" valves to open right; 4 - 2" valves to open left; and 2 fire hydrants to be 3-way and open right, and is shown on a drawing entitled "Westminster Company to Commissioners of Public Works of the City of Greenville, S. C.", dated August 30, 1978, attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to said lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.
